


About Fayetteville National Cemetery

The Cemetery was authorized by President Abraham Lincoln and opened in 1867. It has been placed on the National Registry of Historic Places on July 28, 1999, the Civil War Discovery Trail, and has been declared a National Shrine.

The first burials were the remains disinterred from local Civil War battlefields such as Pea Ridge, Prairie Grove, Cane Hill, and Elk Horn Tavern.

The mission and goal of the RNCIC is to make certain "heroes of America" past, present, and future, know that they will never be forgotten and to especially remember the sacrifices they made so we can be the America we are today.

The Regional National Cemetery Improvement Corporation (RNCIC) was incorporated in 1984 for the expansion of the Fayetteville National Cemetery.



The reason the RNCIC exists is to secure land (when it becomes available) adjacent to the Fayetteville National Cemetery to ensure the Cemetery can continue to receive Veterans for their final resting place. Expansion to any existing national cemetery can only be done by donation of adjacent usable lands. Any acquisition will be donated to the Veterans Administration with an unencumbered title and the land cleared of all structures, utilities, pipes, sewers, etc.
